
## BASIC FAMILY MEDIATION

Taught by Bob Collins, Basic Family Mediation is designed for those who wish to practice family mediation or become better equipped to counsel and represent clients in family matters. It is structured as a comprehensive, practical, and dynamic blend of lectures, discussions, exercises and role-plays. Bob brings to the course years of experience and insights for negotiating support, tools for bringing closure to negotiations, information on ethical issues of practice and answers to the practical questions of beginning as a mediator.

- How to utilize 33 practical mediation techniques
- Tips on making parenting problems palatable
- Easy answers to difficult divorce questions
- Helpful insights into negotiation motivations in divorce
- Creative approaches to child and spousal support
- Avoiding tax traps in family re-organizations
- Applying mediation to family disputes and pre-nuptial negotiations

BOB COLLINS has received such high acclaim from students that we've invited him back to teach the basic family mediation course at the Institute each year since 2001. Bob has practiced family law and mediation for over 30 years, and has received both a Distinguished Faculty Award from the Ackerman Institute for the Family and a Cardozo Law School "Inspire!" Award for his teaching. Bob is a popular mediation trainer of both practicing attorneys and therapists who over the last two decades has shared his insights into the practical skills of mediation throughout the United States, as well as in England, Asia and South America. Bob founded, and continues to serve as Director of the Divorce Mediation Clinic at Cardozo Law School in Manhattan, and is the author of the family mediation training text used at the institute.

LELA PORTER LOVE is the Director of the Kukin Program for Conflict Resolution at Benjamin N. Cardozo School of Law (NYC). Professor Lela Love founded and directs Cardozo's Mediation Clinic, which was one of the first programs in the country to train law students to serve as



mediators. She is the past chair of the American Bar Association Section of Dispute Resolution and a current member of the Council of the ABA Dispute Resolution Section. She regularly conducts courses on mediation and training programs for mediators, both nationally and internationally, and has co-authored several books on mediation and ADR. Lela earned her J.D. from Georgetown University Law Center, MEd. from Virginia Commonwealth University, and A.B. from Harvard University. She is a member of the New York, D.C. and New Hampshire Bars.

JOSEPH B. ("JOSH") STULBERG is the John W. Bricker Professor of Law at the Ohio State University Moritz College of Law. A Distinguished Fellow of the American College of Civil Trial Mediators and a former Vice President of the American Arbitration Association, Josh regularly conducts mediation training for court-annexed



programs, government agencies, and professional and community groups nationwide and internationally. He served as Reporter for the Revised Model Standards of Conduct for Mediators and has been a member of the Supreme Court of Ohio Committee on Dispute Resolution since 1999. Josh earned his J.D. degree from New York University School of Law and his Ph.D. in philosophy from the University of Rochester. He is a member of the New York Bar.

## BASIC CIVIL MEDIATION

BASIC CIVIL MEDIATION, co-taught by Lela Porter Love and Josh Stulberg, is a 40-hour course that explores conflict resolution, negotiation, and mediation theory through lectures, discussions, demonstrations, exercises and role-plays. The course will look at each stage of the mediation process and various attendant strategies and skills. Participants gain a deeper understanding of both conflict and the dynamics, benefits, constraints, and skills needed in third-party intervention in settling disputes.

### What you will learn:

- A deeper understanding of information gathering techniques and communication skills
- Confidentiality in mediation and its limitations
- Legal and policy issues in mediation
- The impact of cultural and other diversity on conflict and conflict resolution
- Mediator orientation and styles
- Ethical issues in mediation

Both instructors bring a wide range of knowledge and experience to this course and will ensure a fruitful learning experience.

Professor Peter Robinson's humor, energy and ability to articulate lessons from his mediation experiences have made him a popular lecturer and trainer; he has presented advanced negotiation and mediation skills courses in more than 30 states, and in Argentina, Canada, England, Holland, Hong Kong, India, Israel, Japan, Jordan, Mexico, France and Rwanda.

Prior to joining the Pepperdine community, Robinson served as the director of the Christian Conciliation Service (CCS) of Los Angeles, a non-profit dispute resolution center, and a staff attorney for a U.S. Government agency that insures pension benefits pursuant to ERISA. He has served on the board of CCS, Ventura Center for Dispute Settlement, Dispute Resolution Services of the LACBA, the Southern California Mediation Association (SMCA), and the California Dispute Resolution Council. The SCMA recognized him as Peacemaker of the Year in 1999. Robinson is a fellow of the International Academy of Mediators and the American College of Civil Trial Mediators. Since 2006, Los Angeles magazine has recognized him as a Southern California super lawyer in the area of mediation.

## THE ROLE OF APOLOGY, FORGIVENESS AND RECONCILIATION IN ADVOCACY AND MEDIATION

This class will examine each of the themes of Apology, Forgiveness and Reconciliation. A spectrum of definitions and meanings of each theme will be explored. A variety of approaches on how to implement each theme will be discussed. The material will be addressed from the context of governing our own lives, providing professional advice to another as an advocate, and serving as a mediator. Class material will include religious and non-religious perspectives on these themes.

### What you will learn:

- A variety of meanings and approaches to apology, forgiveness and reconciliation
- When and how an attorney may recommend that his or her client apologize or forgive
- Issues surrounding a mediator encouraging an apology or forgiveness
