GENERAL ORDER NO. 371

It appearing that the Honorable Terry L. Myers will retire from active service as a United States Bankruptcy Judge for the District of Idaho, effective August 1, 2020; and

It further appearing that a new United States Bankruptcy Judge for the District of Idaho will be appointed to replace the Honorable Terry L Myers, but that the effective date of that appointment is unknown but expected in the near future; and

It further appearing that the Honorable Joseph M. Meier will continue to serve as Chief Bankruptcy Judge for the District of Idaho; and

It further appearing that the Honorable Jim D. Pappas will continue to serve as a recalled Bankruptcy Judge for the District of Idaho; and

It further appearing that it is necessary to assign responsibility for the cases pending and to be filed in this District to the active Bankruptcy Judges;


NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

1. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, pending on August 1, 2020 and previously assigned to Judge Myers with the designation TLM, EXCEPT those bankruptcy cases and adversary proceedings identified in Exhibits "A" and "B" attached to this Order, shall remain designated as TLM cases but will be handled by either Chief Judge Meier or Judge Pappas for all purposes and proceedings until a new Bankruptcy Judge is appointed. All bankruptcy cases and adversary proceedings identified in Exhibit "A" shall be assigned to Chief Judge Meier and have the designations changed to JMM. All bankruptcy cases and adversary proceedings identified in Exhibit "B" shall be assigned to Judge Pappas and have the designation changed to JDP. All

bankruptcy cases, and all adversary proceedings arising therein or related thereto, pending on August 1, 2020 and currently assigned to Chief Judge Meier shall remain assigned to Chief Judge Meier. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, pending on August 1, 2020 and currently assigned to Judge Pappas shall remain assigned to Judge Pappas.

2. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, filed with this Court on or after August 2, 2020, wherein the debtor(s) resides in the following counties shall be assigned to Chief Judge Meier for all purposes and proceedings: Bannock, Bear Lake, Bingham, Blaine, Bonneville, Butte, Camas, Caribou, Cassia, Clark, Custer, Franklin, Fremont, Gooding, Jefferson, Jerome, Lemhi, Lincoln, Madison, Minidoka, Oneida, Power, Teton and Twin Falls.
3. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, where J. Ford Elsaesser is a party, attorney, or trustee, filed with this Court on or after August 2, 2020 shall be assigned to Chief Judge Meier.
4. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, EXCEPT those bankruptcy cases and adversary proceedings where J. Ford Elsaesser is a party, attorney, or trustee, to be filed with this Court on or after August 2, 2020, wherein the debtor(s) resides in the following counties shall continue to be assigned the TLM designation but will be handled by either Chief Judge Meier or Judge Pappas for all purposes and proceedings until a new Bankruptcy Judge is appointed: Benewah, Bonner, Boundary, Clearwater, Idaho, Kootenai, Latah, Lewis, Nez Perce and Shoshone.
5. All bankruptcy cases, and any adversary proceedings arising therein or related thereto, wherein the debtor(s) resides in the following counties shall be randomly assigned by the Clerk of Court to either Chief Judge Meier or designated TLM cases and handled by either Chief Judge Meier or Judge Pappas for all purposes and proceedings until a new Bankruptcy Judge is appointed in such proportion as the Chief Bankruptcy Judge shall from time to time instruct the Clerk: Ada, Adams, Boise, Canyon, Elmore, Gem, Owyhee, Payette, Valley, Washington (and referred Malheur County, Oregon cases).
