It appearing that the Honorable Jim D. Pappas will retire from active service as a United States Bankruptcy Judge for the District of Idaho, effective March 22, 2018; and

It further appearing that the Honorable Joseph M. Meier has been appointed and commences service as a United States Bankruptcy Judge for the District of Idaho effective March 23, 2018; and

It further appearing that the Honorable Jim D. Pappas has consented to serve as a recalled Bankruptcy Judge commencing March 23, 2018; and


It further appearing that it is necessary to assign responsibility for the cases pending and to be filed in this District to the active Bankruptcy Judges;

NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

1. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, pending on March 22, 2018, and previously assigned to Judge Pappas EXCEPT those bankruptcy cases and adversary proceedings identified on Exhibit "A" attached to this Order shall be and are hereby assigned to Judge Meier for all purposes and proceedings. All other bankruptcy cases, and all adversary proceedings arising therein or related thereto, pending on March 22, 2018, will remain assigned to Chief Judge Myers for all purposes and proceedings.
2. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, filed with this Court on or after March 23, 2018, wherein the debtor(s) resides in the following counties shall be assigned to Judge Meier for all purposes and proceedings: Bannock, Bear Lake, Bingham, Blaine, Bonneville, Butte, Camas, Caribou, Cassia, Clark, Custer, Franklin, Fremont, Gooding, Jefferson, Jerome, Lemhi, Lincoln, Madison, Minidoka, Oneida, Power, Teton and Twin Falls.
3. All bankruptcy cases, and all adversary proceedings arising therein or related thereto, to be filed with this Court on or after March 23, 2018, wherein the debtor(s) resides in the following counties shall be assigned to Chief Judge Myers for all purposes and proceedings: Benewah, Bonner, Boundary, Clearwater, Idaho, Kootenai, Latah, Lewis, Nez Perce and Shoshone.

4. All bankruptcy cases, and any adversary proceedings arising therein or related thereto, wherein the debtor(s) resides in the following counties shall be randomly assigned by the Clerk to either Chief Judge Myers or Judge Meier, for all purposes and proceedings, in such proportion as the Chief Bankruptcy Judge shall from time to time instruct the Clerk: Ada, Adams, Boise, Canyon, Elmore, Gem, Owyhee, Payette, Valley, Washington (and referred Malheur County, Oregon cases).
